# ANNOUNCEMENT VERY SUBSTANTIAL DISPOSALS AND MAJOR TRANSACTIONS RESULTS OF THE SGM

#### RESULTS OF THE SGM

At the SGM held on 13th December, 2005, the ordinary resolutions:

- (1) to approve the Disposals on the terms and conditions of the Implementation Deed; and
- (2) to approve the Acquisitions on the terms and conditions of the Acquisition Agreement, were duly passed by the Shareholders.

#### RESULTS OF THE HEH EGM

The board of directors of HEH has announced that the ordinary resolution to approve the disposal of the attributable interests in CHEDHA and ETSA and associated matters was duly passed by the HEH Independent Shareholders at the HEH EGM.

#### COMPLETION OF THE DISPOSALS

Completion of the Disposals will take place on 21st December, 2005 if all the Disposal Conditions have been satisfied.

#### COMPLETION OF THE ACQUISITIONS

Completion of the Acquisitions will take place on 21st December, 2005 if all the Acquisition Conditions have been satisfied.

Reference is made to the circular issued by the Company to Shareholders dated 25th November, 2005 (the "Circular"). Terms used herein shall have the same meaning as those defined in the Circular unless the context requires otherwise.

#### RESULTS OF THE SGM

As at the date of the SGM, the issued share capital of the Company comprised 2,254,209,945 Shares, being the total number of Shares entitling the holders to attend the SGM and vote for or against the following ordinary resolutions:

- (1) to approve the Disposals on the terms and conditions of the Implementation Deed; and
- (2) to approve the Acquisitions on the terms and conditions of the Acquisition Agreement, each as set out in the notice of SGM set out in the Circular.

As at the date of the SGM, there were no Shares entitling the holders to attend and vote only against Ordinary Resolution (1) and/or Ordinary Resolution (2) at the SGM. In addition, the Board confirmed that no persons were required to abstain from voting in respect of Ordinary Resolution (1) and/or Ordinary Resolution (2) under the Listing Rules.

At the SGM, Ordinary Resolution (1) and Ordinary Resolution (2) were each voted on by poll and duly passed by the Shareholders.

The branch share registrars of the Company in Hong Kong, Computershare Hong Kong Investor Services Limited, acted as the scrutineer of the poll at the SGM.

The poll results in respect of Ordinary Resolution (1) and Ordinary Resolution (2) are as follows:
